Minutes of the Indiana Philosophical Association April 10, 1965

The Indiana Philosophical Association held its spring meeting of 1965 on April 10at Marian College, Indianapolis, After a coffee hour the meeting of the senior association was called to order at 10:30 a.m. by John R. Klopke, president. He introduced the first speaker, Robert E. Wood, St. Joseph's College, Rensselaer, who read a paper on "Contemporary German Scholasticism." After discussion of this paper, the second speaker, John J. Doyle, Marian College, Indianapolis, presented a paper entitled "The Square of Opposition and Modal Propositions." Concurrently with the senior association, the junior association met to hear the prize papers of the essay contest under the direction of Robert E. Frye, vice-president.

Luncheon followed the two morning papers. The business meeting of the association was held at the luncheon tables. Father Klopke called the meeting to order and called upon Professor Frye to make the awards for the annual undergraduate essay contest. Bruce Wollenberg of Concordia Senior College was awarded first prize; second place was awarded to Grant Voth of the same institution.

The reading of the minutes of the last meeting was dispensed with in the absence of the regular secretary. (The president appointed Professor Robert McBride as secretary pro tem.) Monsignor Doyle gave the treasurer's report which is attached to these minutes. Fr. Klopke announced that the Fall meeting of the Association would be held on October 15-16 at Catherine Spaulding College in Louisville, Kentucky, in joint session with the Kentucky Association.

Fr. Klopke reported on the results of a survey made to members of the association and suggested that certain changes be made in procedure. One of these would be that the dates of the meetings be established further in advance than heretofore. He also suggested that the practice of the vice-president being the normal successor to the presidency be consistently followed as far as possible in order to assure that programs for future meetings be prepared well in advance. He also announced that a set of addressograph plates addressed simply to "Chairman" of the various departments of philosophy(or equivalent) in the state had been added to the mailing list in order that all schools in the state be assured of information regarding the association's meetings.

An invitation from Indiana Central College to hold the Spring meeting of 1966 on its campus was accepted.

The following names were proposed and accepted for membership: R. Duane Thompson (Marion College), Norbert Schedler (Valparaiso), Edward C. Wojciechowski (Notre Dame), and Richard P. Francis (Notre Dame).

Junior and senior associations met separately after luncheon. The senior association heard a paper entitled "Paul Tillich's Aesthetics" by R. Duane Thompson of Marion College, Marion.
